PUPPY PURCHASE AGREEMENT

The following male or female (list sex) _____ puppy hereby sold to the undersigned for the total purchase price of \$ _____

The Seller, RedLetter Doodles by accepting a deposit of \$ _____ agrees to hold the puppy for the Buyer until release time (week 7.5 - 8). If the puppy buyer wants off the buy list and receive their deposit back within a two week period after the puppies are born, they will get their deposit back minus \$100. Any deposit after the puppies are two weeks old is non-refundable, unless the puppy has the misfortune of dying while in the care of RedLetter Doodles. The deposit will always be subtracted from the total sale price.

The subject animal, to the best of the seller's knowledge, is in good health and free of communicable diseases at time of sale. The puppy will have the dew claws trimmed off, at least one puppy shot and wormed before being released to new owner. A second booster shot at 12 weeks and one more parvo-virus shot at 16 weeks will be needed at the purchasers expense.

Validation of the health of the puppy and this guarantee requires examination of the puppy by a State Licensed Veterinarian of the purchasers choice and at the purchasers expense by the end of the 12th week. That would be the 2nd Puppy exam. The third a puppy exam also has shots must be completed by the end of week 16 for the puppy age. Veterinary examination is mandatory to confirm that your puppy was not sick or injured at time of delivery. The guarantee against transmissible diseases such as parvo-virus is valid for a period of 7 days starting on the day of delivery, since the normal incubation period for transmissible diseases is 5 – 7 day.

The Breeder guarantees the puppy until 2-years of age against all life threatening congenital or hereditary defects. If the puppy has a life threatening congenital or hereditary defect, hips and elbows the cost of the puppy will be refunded and the breeder has the option of requesting the dog back. The purchaser is responsible for any shipping fees. In the event of death, a licensed veterinarian must perform an autopsy to determine the exact cause of death at owners' expense. The report from the autopsy must be sent to the breeders attending veterinarian for review.

This guarantee does NOT cover the following: After seven days hypoglycemia, parvo, coccidiosis, giardia, hernias, ears standing, any types of cancer or the ability or any other standards of this puppy and is sold as pet quality.

The Heath Guarantee not valid if sold to a third party.

The Breeder is not responsible for any veterinarian bills the purchaser may incur regarding said puppy. The purchaser is responsible for any shipping fees and or crates needed to deliver puppy safely to new home. Payment for puppy must be made in full at least 1 week prior to shipping. If you plan to pick up your puppy, your final payment must be made in CASH.

Puppy Spayed & Neutered Understanding

The Buyer agrees to have their puppy spayed or neutered between the ages of 9-12 months. Proof must be sent back the Seller or the Buyer risks having their puppy be returned to the Breeder if proof is not supplied to the Breeder within 10 days after the first birthday of the puppy. **Initial:** _____
